- Bachelors or Graduate level student, with completed coursework in monitoring and evaluation, international development, social sciences, or related field
- Some professional work experience in M&E is highly desirable
- Strong writing and analytical skills
- Seasoned time management skills and attention to detail required
- Advanced Excel skills including facility with formulas, pivot tables and filtering tools
- Strong data visualization skills to create data visualization tools that clearly communicate findings
- Qualitative research experience

Schedule, Duration and Compensation:

Flexible schedule within business hours (9:00 am to 5:00 pm). A firm commitment of at least 16 hours per week is needed for at least three months, with the possibility of extension. Although this is an unpaid educational internship, we provide a stipend for commuting expenses. Arrangements for academic credit can also be made with your college or university, if requested.
